The entire island is available for rent throughout the year subject to availability, including August and the last 2 weeks of October (prior to and just after our annual refurbishing). Please note: additional per person charges apply, should you have more than 44 guests. Maximum adult guest occupancy is 56 in total.

All rates include:

3 meals daily, all non-alcoholic beverages, early morning coffee and afternoon tea, room service, the use of non-motorized water sports and facilities of the resort.

TERMS AND CONDITIONS

All rates are based on up to 44 guests:

- Additional adults ages 15 and over:
Low Season: +\$200/night, High/Peak Seasons: +\$300/night
- Additional children ages 3 to 14:
Low Season: +\$100/night, High/Peak Seasons: +\$150/night
- Accommodations for children ages 2 and under are complimentary

Rates do not include:

- A 11% government tax and a 10% service charge in lieu of tipping (21% total)
- Privately scheduled flights between Barbados and Union Island: \$650/person round trip (children ages 2 and over pay full fare)
- Boat transfers between Union Island and PSV: \$35/person, round trip
- Barbados Airport / Security Service Tax: The Barbados airport departure tax is US\$16.00 per person (US\$33 per person for stopovers of 6 hours or more) flying out of Barbados. Tax for guests departing from Union Island is \$37.20 per person
- Motorized water sports or boat/yacht charters
- Spa treatments
- Alcoholic beverages

Deposits:

- A 25% non-refundable deposit is required to secure the reservation
- A further 25% deposit is required 9 months prior to arrival (refundable up to 6 months prior to arrival)
- The final 50% non-refundable deposit is due 6 months prior to arrival
- Accounts may be settled with cash, traveler's checks, or major credit cards. US dollars, pounds sterling, euro and EC\$ (Eastern Caribbean dollars) are accepted
